Monitoring and Evaluation Plan of Saint Lucia's National Adaptation Planning Process

- It is expected that aside from the annual monitoring and evaluation of NAP progress, **the NAP and SASAPs will be reviewed overall at least once during the 2018-2028 period**
- Ideally, two reviews should occur: in 2021 (end of the period prescribed for initiating the implementation of short-term activities); and in 2024 (end for medium term activities)
